Al can be amazing but as with everything else there are negatives too. Already, the world is seeing some significant and concerning negatives from image-based abuse to voice scams where a persons voice is cloned using Al. Some research suggests that you only need 3 seconds of a persons voice to clone it. Imagine a child who posts videos on YouTube and the data that this holds. Legislation and technical tools to combat these issues will take a long time and therefore education is always the best form of prevention.
